Vocational Rehabilitation Counselor - Diane Acord

Hello from the Vocational Rehabilitation Counselor!

April 1st marked the one year anniversary of the Vocational Rehabilitation office in Minneapolis, Minnesota. It has been a busy year but a good year. On December 22, 2008 the Vocational Rehabilitation office moved from its temporary location at the Regional Service Office in the Henry Whipple Building to its permanent office in the new Spinal Cord Injury and Disorder Center at the Minneapolis VA Hospital in Minneapolis, Minnesota.

For the Minnesota office first year:

- Minnesota office has gone from 0 veterans looking or thinking about employment to currently 97 veterans looking or thinking about employment in 10 states.
- Six veterans are now employed full-time.
- Five veterans are volunteering-which they chose to do.
- Three veterans have received full-ride scholarships for mainframe computer degrees-a joint effort between Marist College in New York and IBM.
- Six other veterans are in training for various occupations.
- Five veterans have interviewed for a new government services division with Kroll Corporation and will be starting in the next few weeks.
- One veteran has been asked to interview with IBM for a computer security position.
- The Minnesota Vocational Rehabilitation office covers the states of Alaska, Arizona, Idaho, Illinois, Indiana, Iowa, Michigan, Minnesota, Montana, Nebraska, North Dakota, Oregon, South Dakota, Washington, Wisconsin, and Wyoming.

Another exciting program starting in the next few weeks will be an ACT Vocational Group. A vocational psychologist and I are teaming together to offer a class that will meet once a week for 6 weeks in the new SCI Center at the Minneapolis VA hospital. The class will give you the tools you will need to succeed in employment and in daily life. ACT stands for acceptance and commitment and will be a new and innovative way to look at interviewing, employment and people. The class will be fun, interactive and hopefully you will find it helpful. If you would like to be part of the group, please call or email me at the phone number and email address listed below; we would love to have you join us! All are welcome and there is no charge.

If you are interested in employment, thinking about employment or just wondering if you would be able to go to work, please come see me. I can assist you with resumes, interviewing, contacting employers, interest testing, accommodations for work, or just discussing the possibility of work or training; what ever it is that you need or have questions about. There are jobs, but in order to land one, you need to be prepared. I can help. One of the things that MNPVA has developed over the years is a great working relationship with our VA hospital leaders and staff. Dianna and I are seeing many more Veterans now that we are located in the SCI Center

I have been asked to represent the MNPVA Chapter on the planning committee for the Minneapolis VA Medical Center for the month of October for the Disability Awareness month to plan activities within the VA Medical Center.

National Service Officer's Report - Tami Andersen

Survivor's Benefits for Widows of Veterans that passed from ALS

What are the benefits that a widow/widower can receive?

During an already difficult time for a widow/widower when their spouse passes away so quickly from Amyotrophic Lateral Sclerosis (ALS), there is some comfort to know that there are benefits from the Department of Veteran's Affairs (VA) to assist them. When the primary or contributory reason for death is a service connected disability or disease; the widow/widower may be eligible for the Dependency and Indemnity Compensation or DIC for short, benefit. The DIC benefit is a monthly monetary award that is paid the first of every month for the previous month of benefit. Currently that amount is \$1,154.00; with an additional monetary benefit for dependents and/or the need for aid and attendance.

Two other benefits are the burial and plot benefits. The VA currently will pay \$2,000.00 to a widow/widower as a burial benefit and \$300.00 as a plot allowance benefit.

What paperwork is needed to submit a claim for DIC and Burial/Plot Benefits?

A VA form 21-534 "Application for Dependency and Indemnity Compensation, Death Pension and Accrued Benefits by a Surviving Spouse or Child" will need to be completed. Along with the VA form 21-534; a certified copy of the veteran's DD214 (discharge document), a copy of the death certificate of the veteran stating the primary and contributory reasons for death, and a copy of the marriage certificate will need to be enclosed.

A VA form 21-530 "Application for Burial Benefits" will need to be completed; along with the VA form 21-530; an itemized paid statement/invoice from the funeral home and a statement/invoice for the plot cost will need to be enclosed.

What is the time frame for filing a claim?

The law for service connection of Amyotrophic Lateral Sclerosis (ALS) became effective September 23, 2008. Therefore, if a veteran passed away from ALS before September 23, 2008, the effective date is September 23, 2008. Otherwise, when a surviving spouse submits a claim within one year of veteran's death; the claim will be effective the date of death. If the claim is submitted after the one year period of date of death, the claim will be effective the date of claim.

How to get started?

Contact your local Paralyzed Veteran's of America National Service Officer (NSO) to set up a meeting to complete the paperwork. The NSO will need to have a VA form 21-22, "Appointment of Veterans Service Organization as Claimant's Representative" completed by the surviving spouse in order to submit and monitor the claim on your behalf. Once the claim has been submitted, the NSO will track it through the VA process to be sure it gets completed in a timely manner and is accurate. Contact your NSO at 612-970-5988 or 1-800-795-3609 with any questions throughout and after completion of the claim.

Government Relations Director's Report - Thomas R. Fjerstad, PRP

The chapter's new office space at the State Capital is basically complete. PVA Awareness Week gave us an opportunity to make visible our new presence on the capital grounds. We held a meet and greet luncheon on Thursday April 16th and for a first time event at this location it was fairly well attended. The 5th floor of the Veterans Building is a great location for gatherings, we liked it so much we will be holding our next chapter Board of Directors meeting there on May 19th. If you would like to check out our new digs just give me a call, I would be happy to give you a tour.

The United Veterans Legislative Counsel met on May 6th, I was in attendance and would like to pass on to the PVA membership to mark your calendars. On June 13th we will have a special opportunity to honor, respect and remember those members of our community who served in the armed forces during the Vietnam era. Minnesota Honors Vietnam Era Veterans is a daylong event featuring guest speakers, KIA roll call, unit reunions, displays, a parade of colors, music, food and more. Listed below are a couple of bills I am currently following that would impact our membership.

HF 541 now included in Tax Omnibus Finance Bill – HF2323

Allows the surviving spouse of a disabled veteran to continue to qualify for the residential homestead market value exclusion for five years after the death of the veteran

HF 671 now included in Environment and Natural Resources Omnibus Finance Bill - HF2123

This provision allows free entrance to state parks to any veteran with a total and permanent service-connected disability. Currently, this is available to Minnesota residents only.

HF 1356 now included in the Transportation Omnibus Finance Bill - HF1309

Amends MnDOT's transit service implementation plan to include provision of free public transit for disabled veterans. Additionally, public transit providers receiving aid from MnDOT are to provide free public transit for disabled veterans.

I am certain that by the time this newsletter actually lands in your hands I will have the final disposition of these bills. Feel free to give me a call or wait for an update in the next newsletter.

I attended a Minnesota Swarm game at the Excel Center on April 18th and became aware of an issue with the facilities seating. I had attempted to purchase season tickets last year and was told that mid-field seats were not available. I assumed this meant that the seats were already sold. It turns out that the accessible mid-field seating on one side has been turned into an area for the media and photographers and an owners suite on the other side. I will be following up on this and will keep you posted as we progress. If you have attended any events at the Excel Center please contact me as I would like to hear about your experience acquiring accessible seating.

The National ADA Symposium will be held June 8-10 in Kansas City MO. This will be the first time the chapter has sent representatives to this symposium. It is reported to be the most comprehensive conference available on the Americans with Disabilities Act and related disability laws. I will be in attendance along with chapter President Charlie Wittwer and Sports Director Todd Kemery. We registered specifically for the ADA Coordinators' Program which is designed to meet the specific needs of ADA Coordinators of state and local governments, educational institutions, and other entities. Completion of the ADA Coordinators' Program will help one to better understand the role of an ADA Coordinator, understand the philosophy of full inclusion and the main concepts of the ADA as a civil rights law, be familiar with ADA regulations and guidelines, know how to coordinate and conduct a self-evaluation and transition plans, know how to establish on-going assessment and evaluation procedures, and acquire a working knowledge of ADA resources. Look for our report in the next newsletter.

# PARALYZED VETERANS OF AMERICA MEMBERSHIP APPLICATION

An individual is eligible for membership by meeting the following criteria: (1) is a citizen of the United States; (2) was regularly enlisted, inducted, or commissioned, and was accepted for or on active duty, in the Army, Navy, Marine Corps, Air Force, or Coast Guard of the United States or an ally of the United States; (3A) was separated from the service in the Armed Forces under conditions other than dishonorable; or (3B) is on active duty or must continue to serve after the cessation of hostilities; and (4) has suffered a spinal cord injury or disease (such as MS, ALS), whether or not service connected in origin. Membership is free. Complete and mail the application to: PVA Membership Department, 801 18th Street, NW, Washington, DC 20006 or to the chapter of choice.
